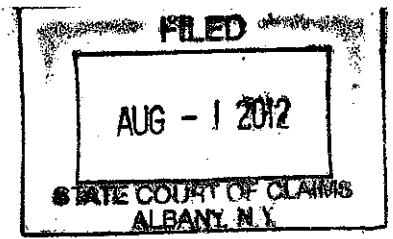

**WHEREAS**, the parties hereto have agreed to settle claim pursuant to the provisions of Section 20-a of the Court of Claims Act, and

**NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED**, by and between the undersigned, the attorneys of record for all of the parties in the above-entitled action, that whereas all parties in the above-entitled action are adults or corporations, and no person not a party has an interest in the subject matter, the above entitled action be, and the same hereby is settled, and upon payment of the sum of **TWO MILLION DOLLARS (\$2,000,000.00)**, discontinued with prejudice, pursuant to Section 20-a of the Court of Claims Act. Payment shall be made by check as follows: a check in the amount of **TWO MILLION DOLLARS (\$2,000,000.00)** made payable to Michael Clancy and the Law Office of Ronald L. Kuby 119 West 23rd Street, Suite 900, New York, New York 10011.

We, the attorneys for the claimant, do hereby release and waive our lien for services upon




This stipulation may be filed without further notice with the Clerk of the Court.




